Things to know about the survey and the results

- To be used to assess and monitor the situation on campus related to sexual misconduct and how it is handled by the school
- To be conducted at least every two years
- Responses are anonymous
- Results are not to be used to launch investigations
- Does not impact the ability of someone to file a complaint
 - There is no time limit on complaints
- As a result of the small sample size (73 students out of 91) the the raw data will not be publically released to avoid the possibility of attribution of specific answers to specific students

Important Numbers

- Number of Students 91 (Includes SOTON)
- Number of Responses 73 (61 Complete)
- Percent Participation 80% (67% Complete)
- Small Sample Size

The survey investigated

- Prevalence of "Sexual Misconduct" that students
 - Experienced
 - Observed
- Student awareness of Title IX
 - Coordinator
 - Policies
 - Grievance Process
 - Aspects of NYS "Enough is Enough" Legislation
- Student Reporting
- Student experience with the grievance process

Sexual Misconduct: Conduct that would qualify as sexual harassment

- Comments of sexual nature
- Jokes of a sexual nature
- Gestures of a sexual nature
- Rumors about sexual orientation
- Rumors sexual in nature
- Asking for sexual favors
- Flashing

- Mooning
- Touched in a sexual way
- Grabbed in a sexual way
- Pinched in a sexual way
- Brushed up against in a sexual way

The survey instrument stated "Please note you should only report experiences that were unwelcomed."

Sexual Misconduct: Conduct that would qualify as sexual assault

- Touched in a sexual way
- Grabbed in a sexual way
- Pinched in a sexual way
- Brushed up against in a sexual way
- Raped

What the survey did not do?

- Did not measure
 - Whether certain acts fall under the definition of sexual harassment or sexual assault as per NYS definitions
- Did not identify the specifics of a reported occurrence
- Did not identify if occurrences
 - Were unique events (multiple people could be reporting the same event)
 - Were the actions of one individual or multiple individuals
- Did not identify if acts were carried out by
 - Students
 - Faculty members
 - Members of the staff and administration
 - Subcontractors
 - Guests on campus

Aware of on and off-campus resources	92% (3 out 5 or greater)
Aware of difference in how state and school defines sexual harassment/misconduct	67% (3 out 5 or greater)
Understand the definition of affirmative consent	92% (3 out 5 or greater)
Filed a Title IX grievance	1%
