GETTING THE JOB DONE IN A THRIVING WEBB BUBBLE

At the Board of Trustees meeting on October 15, 2020, I announced plans to retire on June 30, 2022.

Time passes by so quickly at Webb. It seems like only yesterday that we were planning for our six-year Campaign for Webb, initiating implementation of the 2013 Strategic Plan, and were in the early planning stages for much needed infrastructure enhancements to Webb's campus. We have now completed our successful Campaign, are fully immersed in the implementation of the 2019 Strategic Plan, and are putting to good use our recently completed Couch Academic Center. We have installed a faster and more reliable information technology network, new septic systems, and a new watermain. Work to repurpose the Stevenson Taylor Hall classrooms to dormitory spaces is well underway. The dormitory rooms will be ready for occupancy at the start of the Spring 2021 semester. The Thorpe Athletic Field has been repitched and fitted with a sprinkler system. Thanks to the generosity of the Class of 1975, red oak and sugar maple

trees have recently been planted along the periphery of the field (see below).

Webb has remained COVID-free since the outbreak began in the early spring. All students are on campus for this fall semester, with most of the classes and all labs being taught in person. Our students have demonstrated resiliency and a sense of responsibility throughout the pandemic. The isolated location of the Webb campus, lamented over the years by our more gregarious students, is now a great asset. We have created a Webb bubble, limited travel to more essential needs, and enjoyed the safety of the confines of the Webb campus. Thanks to the generous gift from the classes of 1977 and 1988, and to the hard work of Paul Vibrans '71, the automated gates we recently installed at the entrances to campus have served us well, limiting the number of uninvited guests roaming the grounds.

Faculty and staff have done an outstanding job of dealing with the challenges posed by COVID-19, including

navigating a smooth transition to distance learning last March. I have not heard a single complaint all year—we are just simply getting the job done. We are now formulating plans for 2021. Winter Work will proceed as usual, with the exception of the Sophomore Sea Term, which will be postponed until the summer of 2021. We expect all students to return to campus for the spring semester. While COVID-19 protocols will remain in place at the start of the spring semester, we all anxiously await the development of an effective vaccine and remain hopeful that we can hold an in-person Homecoming event on May 22nd. The final decision regarding Homecoming will be made in mid-March. Stay tuned.

The class of 2020 designed and partially funded a gazebo being built in memory of my wife, Peggy. The gazebo, located adjacent to the Student Garden, has a majestic view of Long Island Sound. It will no doubt be a popular hangout for future generations of Webb students. The Class of 2020 planned on completing construction prior to graduation, but the pandemic got in the way. Students are continuing work this semester with the intent of

completing construction prior to the Class of 2020 Commencement exercises currently planned for May 1, 2021. For those filling out your calendars, graduation for the class of 2021 will be on June 12th. We are eliminating spring break and completing the spring semester a week earlier than normal, thereby allowing additional time for the Sophomore Sea Term.

We continue to attract 28 outstanding freshmen each year. In the last ten years, the number of applicants has more than doubled. As explained in the *Message from Chairman of the Board* Bruce Rosenblatt (see p. 4), our commitment to diversity, equity, and inclusion includes a goal of further diversifying the student body. We are seeking to increase the number of female students which has hovered around 24% over the last five years. In the two years since we established room and board scholarships to meet full "demonstrated need," we have realized sharp increases in the number of economically disadvantaged students and a three-fold increase in the number of underrepresented minorities.


As we transition out of the *Campaign for Webb*, fundraising has continued to exceed our budgetary projections. Thanks so much for your support of Webb! Once again, both alumni and parent participation rates exceeded 70%. These numbers make Webb the envy of development programs nationwide. Last March, we rebated a portion of room and board payments when we sent students home because of the high COVID infection rates in the State of New York. The parents and students demonstrated their commitment to Webb by returning a portion of those refunds as gifts to the college.

As I complete my fourth year as Chairman of the Board, I am grateful for the progress made possible by the hard work and dedication of Webb's family. As you learned from the President's message, Keith Michel '73 has announced his well-deserved plans to retire in June 2022. It is too early to recount his extraordinary achievements as President as he continues to guide Webb to present-day successes. Although I am profoundly sad that his retirement is now on the horizon, and I fully recognize that his imminent departure leaves a tremendous void to fill, I am confident that our Presidential search will produce a competent visionary who will propel Webb to even greater heights.

I'm sure you recall that last year the Planning Committee, led by Trustee David Bovet '70, completed our Strategic Plan. As the next step, Webb's Administration has developed a detailed Implementation Plan which serves as a roadmap to Webb's continued success in every facet of Webb operations. I am grateful to everyone involved for their efforts to ensure that Webb's priorities articulated in the Strategic Plan are being realized. Early reports by the Administration are encouraging.

At its annual meeting on October 15th, the Board of Trustees reaffirmed its commitment to a resolution promoting diversity, equity, and inclusion (DEI) at Webb. A special thanks to Trustee George Campbell for chairing the Board's DEI Committee, and for championing an initiative in consonance with our mission and our understanding of the intentions of our founder, William H. Dear Friends,

As we entered Webb's 2019-2020 fiscal year, we knew that from a fundraising standpoint, we would have to work hard to achieve annual giving results similar to those reached during the recently-concluded, highly-successful *Campaign for Webb*. Little did we know that the challenge of the pandemic was just around the corner. Not only would it impact our personal lives, but it would impede Webb's ability to provide in-person education to its entire student body. It was also necessary to cease all non-essential visits to campus. We enthusiastically look forward to the day when Webb can once again welcome you in person.

In spite of these challenges, Webb's administration, Development Office staff, and volunteers employed creativity and frequent outreach to compensate for our inability to interact with alumni, parents, and friends as we have in the past. The annual phonathon during which pledges are solicited was replaced with Webb Cares, whereby hundreds of outreach calls were made by 24 Webb students to check in and share experiences with many of Webb's older alumni. A COVID-19 fund was established to assist with increased operating costs related to the pandemic. It has been generously supported. When pro-rated rebates for room and board were sent to families of students who returned to their homes because of the pandemic, many returned these rebates to Webb as charitable donations. These are only a few of many examples illustrating the unwavering generosity of the Webb family. In their entirety, these activities and others led to strong fundraising results for the fiscal year. Nearly \$2.5 million in total contributions were received last year. Webb's alumni once again strongly supported the Webb Alumni Fund by donating over \$2.0 million with 70% of alumni participating. Similarly, parents of Webb's current students, as well as parents of alumni, gave generously with high levels of participation, while significant donations from members of Webb's Heritage Society

were received. These results would not have been possible without the hard work of many people. My personal thanks go to my colleagues on Webb's Development Committee for their dedication, thoughtful perspective, and stewardship. The Committee is deeply appreciative of the volunteer efforts of Webb Alumni Fund Chair Jake Neuman '93, Webb Planned Giving Chair John Malone '71, and Webb Parent of Alumni Fund Chair Hal Granger P'14 (Hon.) for their continued leadership of Webb's volunteer fundraising committees. Webb Parent Annual Fund Co-Chairs Jen '91 and Tom '89 Waters P'20 and Jeanine and Paul Becker P'21, P'22 worked together to lead the strong parent fundraising effort this year. Jen and Tom's daughter Linda has now graduated. We thank them for their highly effective leadership over the past four years and are grateful to the Beckers for continuing to serve in the role as co-chairs this year. Tom has graciously agreed to co-chair the Parent of Alumni Fund committee with Hal this year. We all appreciate the work of each of the class agents, parents, alumni, and friends of Webb who have donated their time and energy to personally contact Webb's donors and prospects.

Our volunteers continue to be ably and enthusiastically supported by Webb's Development Office staff. Under Anthony Zic's leadership, Joe Cascio, Shanna Hamilton, Gailmarie Sujecki (Hon.), and Alicia Edgar have worked together, and with their Webb colleagues and the Development Committee, to continuously enhance and expand the fundraising reach of the institution.

These have been challenging times, yet the financial support provided by Webb alumni, parents past and present, friends, and foundations has been extraordinary. We do not take your support for granted, but rather value your confidence and strive to be exemplary stewards of the donations you have entrusted to Webb. *Be well and thank you for your continued support of Webb*.

William "Bill" Blanton, Jr., P.E. '71 was quite the character, as I learned from his daughter, Mrs. Catherine Blanton Harrison, and others who remember him lovingly. He has been described as quiet but social, a great storyteller, funny, and at times intimidating because of his intellect.

Bill was also a prankster. The neighboring Woolworth estate in Glen Cove became the Grace Downs Air Career School, an "academy for young women who like fine adventure and travel plus a salary." At the time, Bill was courting one of the young women from the Grace Downs Air Career School, as did a number of Webbies. As Webb Social Chair in charge of all of Webb's mixers, he always found a way to incorporate the Grace Downs students. On one Halloween night, Bill adeptly made it nearly impossible for boarding students to leave on All Saints Day to go to church.

Perhaps inspired by his father, William J. Blanton, Sr., an architectural engineer, Bill had a strong love of the sea and sailing, a passion he pursued throughout his adult life. He went to the Collegiate School in Richmond, a private prep school. Bill learned of Webb through his prep school classmates. After applying to Webb, Bill received a thin envelope that he decided he would never open. He was convinced that the thin envelope meant he had received a rejection letter. One day, Bill's prep school friends asked what a rejection letter looked like. Bill sheepishly held up the envelope from Webb. His friends opened the letter and began to read it aloud. To Bill's surprise, it was an acceptance letter. The joke was on the prankster this time, he had gotten in. Then Webb president, Admiral Brockett, made it known to Bill that his was a "risky acceptance," and that he should not take his admission to Webb for granted. Bill took this to heart. He applied his passion for academics and graduated from

Webb with pride.

After graduation from Webb in 1971, Bill joined the United States Coast Guard and served until 1976. He went on to receive his Master of Science degree in mechanical engineering from George Washington University in 1976, and his Juris Doctorate from George Mason University School of Law in 1996, where he served as director of the legal research and writing program from 1997-2001. He was a licensed professional engineer and became the Founder and President of Chesapeake Materials, Inc.


Bill became a member of Webb's Board of Trustees in 2007, where he was joined by then Trustee and current Webb President Keith Michel '73, who recounts, "Bill was an extraordinary person and he served on Webb's board with distinction. To recognize Bill's generosity and in light of his passion for sailing, the sea and the

GIVING BACK TO WEBB:



AN INTERVIEW WITH WEBB ALUMNI ASSOCIATION PRESIDENT, VICKY DLUGOKECKI '88

Victoria "Vicky" Dlugokecki '88 was voted in as President of the Webb Alumni Association (WAA) on May 16, 2020. I recently caught up with Vicky on her thoughts about giving back to Webb:

Q: Was philanthropy emphasized during your time as a Webb student? Were you encouraged by the administration, faculty, or trustees to engage in this context?

I don't remember philanthropy or the support of the Webb Alumni Fund (WAF) being emphasized while I was a student in the mid-1980s. The Heritage Society didn't exist and neither did the Webb Every Year (WebbEY) Program. I also don't remember anyone receiving scholarships. I'm pretty sure that Professor Larry Ward, Webb Class of PG'51, was the WAF Chairman at that time—as a student and a recent graduate, I really don't remember a time when Larry Ward wasn't the WAF Chairman. I remember thinking that the Trustees must have been big donors...names like Charles Visconti '55, "Pete" Bethge '53, GP'05, and "Joe" Cuneo '57. And then there was J. J. Henry '35 and Lester Rosenblatt (Hon.), both with endowed chairs associated with their names... All titans in the marine industry in my mind! I figured that when I became a titan, I would be in a position to give back to Webb like they did.

Q: Why do you give back financially to Webb? Why do you give your time?

I definitely don't put myself in the same giving category as the names I just mentioned, but I've always recognized that the benefit of a full-tuition scholarship is something

that should be given back to the school. And I was perfectly okay knowing that I could achieve this through relatively small contributions during my lifetime.

I've been generous with my time as far back as I can remember. While one might not call it volunteering, I had quite a few leadership roles as a teenager, including editor of my high school newspaper, drum majorette of my high school marching band, and captain of the swim team. At Webb, I was the Business Manager of the Webb *Binnacle* for three years, selling advertisements to support the printing of the publication. That's when I first met Ed Primeggia, director of Webb's Development Office during my time at Webb, who encouraged giving back to the school. In my early years in New York City, I volunteered as member of the NY Metropolitan Section of SNAME. I've rarely missed a SNAME Annual Meeting, a Webb Alumni Banquet, or a Webb Homecoming event. I volunteered to be on the WAA Executive Committee, way back in 2010, for the Secretary / Treasurer position, and I stayed on as Treasurer for many years, before finally deciding to turn that over and move up in the WAA leadership roles, culminating in my becoming WAA President this last May. My Mom always tells me that time is money, and that I volunteer too much, but I guess it's just in my blood. I've always been a "joiner," and I guess I'll always be one. Participating as part of a community gives me satisfaction.

Q: How will your role as Webb Alumni Association President impact alumni giving?

When I was first elected as WAA President, someone asked me if I had a "mission" or a "theme" for my presidency. After I gave it some thought, I decided that I wanted my tenure to be associated with the word "Community." With many of us still hunkered down because of the COVID-19 pandemic and with the social unrest in the U.S., this is really an opportunity for the Webb family to shine. While we were at Webb, many of us built life-long friendships with classmates, and we have grown many more close alumni connections throughout our careers. I will try to use these connections to facilitate a closer connection to the school and to influence financial support of Webb. As WAA President, I now participate on the Communications Committee of the Board of Trustees. I think that my role as WAA President and Trustee will have a positive impact on alumni giving.


Q: What inspired you to establish the Dlugokecki Family Scholarship fund?

Sure, I read the *Webb News* "Heritage Society Spotlights" and browsed through the "Webb Scholarship: Making Progress by Getting Closer to 1967" article in last year's Annual Report, but it wasn't until I had the opportunity to participate in the Board of Trustees' Diversity, Equity, and Inclusion Committee meetings that I realized that a number of very talented students don't

accept their offer to attend Webb because they received "better deals" from other colleges. We all know that Webb provides a full-tuition scholarship, but the cost of room, board, and fees exceeds \$18,000 for first-year students. I came from a middle-class family. My brother Chris and I were the first sister and brother to graduate from Webb,





and we were both first-generation college students.

My dad was with the NYPD—a "beat cop," not a high-ranking NYPD member like a sergeant or a detective. My mother was a bookkeeper for a factory in Long Island City. I was 12 when I got my first job as a Little League umpire for eight year-olds. We are a hard working family. Could our family afford the \$3,000 to \$4,000 room and board from 1980s Webb? Sure. But affording room and board in today's economy seems a lot tougher. Plus, Webb is competing with all the top schools for the best students. And while William H. Webb's endowment and the generous support of the Webb family have been able to sustain the full-tuition scholarship model for more than 130 years, our ability to recruit the best students is sometimes deterred when students have significant financial need.

President Michel '73 told me about a recent graduate who set up a room and board scholarship fund for leadership students with demonstrated financial need. I thought this was a great story, but the young grad is humble and didn't want to publicize his good deed. So if a recent grad can do it, why can't I? I called Anthony Zic, and after we exchanged a couple of emails on setting up the fund, Webb will award the Dlugokecki Family Scholarship! I won't be as humble as our young grad, and I will try to inspire others by sharing the news in this Annual Report. This scholarship will provide room and board stipends for students with a demonstrated financial need. Preference will be given to students who enhance diversity at Webb through support of students from underrepresented backgrounds, including women,

first-generation college students, and/or students from minority backgrounds. While funding this scholarship, I also plan to continue to make unrestricted gifts to the Webb Annual Fund—these gifts have and will continue to be critical to Webb's long-term sustainability, including full-tuition scholarships.

Q: If you knew individuals who had the means to give and they were philanthropic but unfamiliar with Webb, what might you say or do to try and convince them that Webb should be the beneficiary of their support?

I don't think anyone will ever convince me otherwise— Webb is a college like no other. If I met someone who I thought was in a position to make a gift to Webb, I would do my best to summarize my Webb experience. Where else can a student expect to spend almost every waking moment with 27 of his or her classmates and have your professors come to your assigned classroom? Where does a gong ring to summon you to lunch and dinner? What school does a better job blending a firstclass theoretical education with two months of practical industry experience each year, while working toward a dual Bachelors in Science? Where else can you go to school where 100% of your classmates have one or more job offers before graduation, year after year? Where else do you become part of a family from your first day of Freshman Orientation through the rest of your life?

I donate to many worthy organizations—cancer research, childhood illnesses, veterans, our military, and first responders—but none of that is as satisfying as what I give back to Webb!





REMEMBERING PROFESSOR JENS HOLM:

INSPIRING WEBB'S NEWEST COMMENCEMENT AWARD


George A. Gilmore, Webb Class of 1957, had a remarkable and unique journey—before, during, and after his time at Webb.

After graduating from Webb, George joined Dravo Corporation working in barge, towboat, and tug design. He then attended Navy Officer Candidate School where he was Battalion Commander and spent two years as Ship Superintendent in the Submarine Repair Division of Pearl Harbor Naval Shipyard. Subsequently, he was Damage Control Assistant aboard reserve training vessel DD658 in the Pacific for two years.

George attended Harvard Business School, graduating in 1964 with a master's degree in Business Administration. He spent time with Marine Transport Lines and was involved with ship acquisitions, and then joined United Fruit Company, analyzing banana shipping systems. Then followed a stint with Ocean Science and Engineering, where he developed buoys for weapons testing and undersea cable marking at sea; and at Ocean Mining, he pursued lease acquisitions for tin mining in Indonesia.

In 1970, George obtained his professional engineer's license and established a consulting practice in Washington, DC. He directed marine oil spill control studies for the American Petroleum Institute and undertook hull design of dredges and tenders for dredging contractors. In 1975, he joined Energy Transportation Corporation as Administrative Vice President for the construction and operation of eight U.S. flag LNG vessels, and a tug/barge ammonia carrier. In 1985, George returned to Brunswick, Maine, to oversee his family's business, Senter's Department Store. After closing the store in 1992, this property continues to be managed as a leased space. George has also managed several other commercial properties in Maine. He and his wife Martha have three children and seven grandchildren.

While George's professional and educational experiences post Webb are impressive, he would argue his time at Webb had a few bumps on the road. George loved the sea, sailing, and all things nautical. It was in his DNA. His great grandfather sailed around the world as the Captain of *Solitaire*. He and his wife lived aboard the vessel, and since they did not have children of their



own, they decided to adopt a young girl from Boston. Emma, George's grandmother, sailed with her adopted parents until the age of 14, at which time the *Solitaire* was shipwrecked, putting an end to the family's world-wide sailing journey.

George had been accepted to other prestigious programs and institutions, including the Massachusetts Institute of Technology (MIT), which in partnership with Bowdoin and Williams offered a 3+2 program culminating in a Bachelor of Arts and a Bachelor of Science in Engineering. He read about Webb Institute of Naval Architecture in the *Saturday Evening Post's* December 10th issue in 1949. Once he received his acceptance to Webb, George's mother made his college selection quite simple, as he remembers her saying sternly: "You're not passing up the full-tuition scholarship." Although not a Webb graduate, George's mother was no less practical or direct.

While at Webb, George enjoyed basically everything. He played tennis, basketball, sailed, played the clarinet, and sang, among other extracurriculars. "I liked doing it all, maybe a bit too much," said George. His unquenchable thirst to conquer it all left too little time for Webb studies, and he would be dismissed academically for failing Marine Engineering (taught by Professor Jens Holm, a subject he loved), and Fluid Mechanics (which he loved less) in his junior year.



This is where George's story, and inspiration to memorialize Professor Holm, begins. Admiral Haeberle, then Webb President, decided he would accept George back if he passed proficiency exams, under the condition that he would not engage in any extracurricular activities. Second chances at Webb were even less common then than they are now, so this would be a tough road to travel. To play it safe, George called MIT and began to line up "a plan B," just in case.

Professor Jens Holm, Webb graduate of 1941, would no longer teach Marine Engineering the following semester at Webb, and he was concerned about George's predicament. He was teaching at Columbia University at the time, so he invited George to come into Manhattan once a week for tutoring sessions. Each week, these two had a standing meeting at a cafeteria-style restaurant. This made the dining portion of their meeting efficient so that they could focus on the primary task at hand. George would receive weekly homework assignments which Professor Holm would scrutinize in great detail. George remembers Professor Holm as a friendly man who did not particularly care for small talk or gossip.

Professor Holm served as a naval constructor at Mare Island Naval Shipyard and in the South Pacific before discharge in 1946 with the rank of Lieutenant Commander. After a brief period with the New York Shipbuilding Corp., he was invited to join the faculty of Webb as Professor of Marine Engineering, a position he held until his retirement in 1980. His devotion to his

students and their education were recognized by naming him Professor Emeritus of Marine Engineering in 1983. He was involved with the marine industry as a consultant and a contributor of technical literature. His clients included machinery manufacturers, ship owners such as the Onassis Group, and naval architects such as the J. J. Henry Co. Professor Holm's technical literature contributions included SNAME Technical & Research Bulletins and papers, membership on the Control Committee, and authorship of the chapter on thermodynamics and heat engineering of SNAME's 1971 reference text Marine Engineering. His honors include designation as an

Honorary Member of SNAME, Webb Alumni William Selkirk Owen Award recipient in 1975, and SNAME's David W. Taylor Medal recipient in 1983.

At the conclusion of the summer, George passed his proficiency exam and he gladly accepted his invitation to rejoin Webb. He was happy to spend a year in a triple occupancy dormitory room, and his wonderful memories at Webb resumed.

George has been a staunch supporter of Webb since his graduation in 1957. As he was reviewing the list of Webb's Commencement Awards, George noticed that this list did not include an award solely dedicated to excellence in Marine Engineering. To honor Professor Holm, he funded a permanently restricted endowment to establish the Jens T. Holm '41 Memorial Commencement Award. Beginning in 2020 and every year thereafter, Webb will make an award to a graduating senior who demonstrated outstanding achievement in Marine Engineering.

"Webb is fortunate to have George and Martha as part of the Webb family. Their efforts to establish this Commencement Award is a fitting tribute to Professor Holm, and another example of their wonderful giving spirit," said President Michel '73.

Webb is grateful for the support of George '57 and Martha Gilmore!

SUSTAINING A WEBB CURRICULUM THROUGH COVID-19

There is a saying that sometimes it's better to be lucky than good.

That is what sprang into my mind as I walked into the Sophomore Design Studio for my first lecture of the fall 2020 semester. It was already the third week of the semester, as we had just completed two weeks of remote instruction. Delaying in-person instruction allowed us to accommodate out-of-state students whom New York State required to quarantine for two weeks. We

also administered COVID-19 tests to the entire student body, and all students tested negative. From the faculty's perspective, we started the semester where we ended the last. For the upperclassmen on campus, returning to Webb was the first step toward a return to normalcy.

In the Work Studio, the twenty-six sophomores were seated at their individual workstations, wearing face masks, and separated by six feet in all directions. The large interactive flat-panel monitor was located at the front of the room along with an instructor's podium, placed six feet from the nearest student desk. The floor-to-ceiling white boards at the front of the room were newly cleaned. The Sound-facing windows were open, as was the door leading out to the external staircase. If you were

asked to design a classroom to accommodate COVID-19 requirements, Webb's Design Studio may well be the blueprint. But COVID-19 did not dictate the original design of this space; the Design Studios were sized to accommodate up to twenty-eight design stations, a small seating area, and space at the front of the room where the course instructor could manage a design lab. It turns out that the footprint needed for the original plan was just large enough to support a socially-distanced class of twenty-eight students and an instructor. Luck was on our

side as we strived to return to in-person instruction. At the time, I hoped that this was a sign of things to come. When speaking to the faculty and students at the beginning of the semester, I noted that the key to this semester's success would be flexibility. We had no idea what additional requirements would stem from COVID-19, but if we remained flexible, the Webb educational experience would continue as students and faculty worked together. Our flexibility resulted in an unprecedented ability to deliver the Webb curriculum with only 50% in-person instruction, and all students are living and learning on campus. All classes including labs, both in-person and remote, are provided synchronously and continue without interruption. Technology continues to be crucial to the daily delivery and management of the educational program. The lessons we learned in the spring are serving us well in the fall, and we continue to build upon what we have learned. Necessity truly is the mother of invention.

As we have passed the halfway point of the fall semester, the next challenge before us is the upcoming Winter Work period. The decision has been made to go forward with this year's Winter Work program although COVID-19 has limited internship opportunities. We believe that this program is so valuable and formative for our students that we want to make sure our seniors can take part in their fourth internship experience. For those students whom we cannot place this winter, we intend to make this up in the summer of 2021 so that we remain on schedule.

With continued luck, teamwork, and flexibility, I am confident that the fall semester will finish successfully, and that we will be prepared for whatever the world throws at us when spring classes begin on March 1, 2021. Two things are for certain, the learning will continue, and Zoom is here to stay. Be well and stay safe.

SOLID PERFORMANCE IN THE MIDST OF CHANGE AND UNCERTAINTY!

At first glance, the 2019-20 Webb Alumni Fund (WAF) total raised of \$2,027,089 might seem underwhelming with the backdrop of the successive record-breaking WAF years. But when you consider just how different this giving year was from most, reaching the \$2 million plateau was a difficult task, one that could only be accomplished through your generous gifts during these uncertain times. When we planned for this WAF year, we knew all too well that you have been asked to stretch your giving capacity during the six-year *Campaign for Webb* effort. Then unexpectedly, in the last quarter of the giving year, COVID-19 disrupted our lives.

Most Webb students learned remotely during the spring semester. Many alumni experienced professional hardships. Our Spring Phon-a-thon was replaced by Webb Cares—phone outreach conducted by Webb


I look forward to a great WAF 2020-2021 as we strive to raise \$2,100,000 and secure the participation of 75% of undergraduates.

Bill served on the Webb Board of Trustees and was instrumental in overseeing the rip-rap replacement of Webb's deteriorating sea wall along Long Island Sound. He passed away in January 2012, and his estate was settled recently, allowing the disbursement of his planned gift. In recognition of his service and contributions to Webb, the Board's Gift Acceptance Committee recommended, and the Board approved, naming Webb's waterfront path Bill Blanton

We eagerly look forward to seeing new and familiar faces at next year's Heritage Society Reception and Dinner at the President's House, scheduled on May 21, 2021. A record high attendance is likely, given that the Class of '70 (belatedly celebrating the 50th anniversary of their graduation from Webb) and the Class of '71 (celebrating their 50th anniversary) will be invited in their entirety. 

FINANCE & INVESTMENTS FY2020

In this first fiscal year following the completion of the sixyear Campaign for Webb, fundraising revenues remained strong and exceeded budgetary projections. Thanks to all of you who contributed to this strong performance! Elsewhere, Webb's income statement for FY2020 was significantly affected by the pandemic. In compliance with directives from the Governor of the State of New York, the majority of students were sent home in March, and their room and board charges for the remainder of the semester were reimbursed. As we had fewer students on campus, expenses related primarily to reduced culinary and janitorial services declined, partially offsetting the loss of room and board revenues. As shown on the income statement presented in Table 1, Webb sustained a loss of \$4.2 million in FY2020. This loss does not reflect \$1.1 million in grants and loan forgiveness that Webb has subsequently received under the CARES Act. Instead, this amount will be reflected as extraordinary revenue during FY2021.

Endowment investment losses as of June 30, 2020, of \$1.4 million reflect the sharp market drop in February and March. The endowment regained some of the losses it sustained at the low point of the market and continues to show positive returns in early FY2021. Webb's endowment ended the fiscal year with a net loss of 2.1 percent. On June 30, 2020, the trailing ten-year average annual returns slightly exceeded 7.0 percent. However, the overall endowment returns for FY2020 are disappointing, and the Webb Investment Committee has been hard at work evaluating our asset allocation and manager performance.

In 2017, Webb initiated a much needed \$21 million infrastructure enhancement program. The Couch

Academic Center is complete, and it has been in use since the spring semester. Many of the other projects, including the renovation of the Stevenson Taylor Hall (STH) east side bathrooms, new septic systems, a new water main, and upgrades to the computer network, are now complete. Other projects including repurposing of the STH classrooms to dormitory rooms, installation of an ADA compliant elevator, and fitting of a sprinkler system throughout STH are underway and will be completed before commencement of the spring 2021 semester. We also anticipate completion of the renovation of the STH

west-wing bathrooms by the spring semester. These projects are supported by restricted funds received during the Campaign and financing of approximately \$8 million. By collateralizing the financing with selected investments from our portfolio, we have access to attractive borrowing rates (currently 1.25%). The Board has approved a policy statement to pay all accrued interest on a quarterly basis, and the principal over 30 years, with consideration given to accelerating the repayment schedule as Campaign pledges are received.

The draw on the endowment is used to support operations and routine capital projects. Webb's Board of

Trustees has established a target draw rate of 4.25% per annum. Over the last 10 years, the draw rate excluding major gifts (gifts from individuals whose cumulative unrestricted annual giving is \$100,000 or greater) has declined from a range of 7.5% - 8% to the FY20 value of 5.1%. We still have work to do to bring the actual draw rate down to the target rate, but we are making steady progress. When major unrestricted gifts are included in revenues, the draw rate in recent years has been under the 4.25% target rate.

Each year the Finance Committee of the Board carries out a long-term financial assessment of Webb's finances. Based on the Committee's best estimates for factors such as market return, inflation, and fundraising growth, the Committee projects that the draw rate will remain flat over the next 10 years. The Committee also projects that the endowment will grow at a very modest rate as we pay down the debt assumed to finance our infrastructure enhancements, and await the receipt of planned gifts included as soft pledges during the recent Campaign.

The Board of Trustees and the Administration are committed to Webb's long-term financial health and the sustainment of our full-tuition scholarship model. Over the prior seven years, we have kept increases in expenses under the CPI while achieving robust growth in fundraising revenues. Key factors to a successful financial future remain the same: continue the growth of Webb's Annual Fund in excess of inflation, limit increases in budgeted expenses to the rate of inflation, expand Heritage Society membership and work purposefully with existing Heritage members on their intentions regarding planned giving, and, pursue other sources of funding from outside of the Webb family and/or from new revenue sources.
